This includes distribution of goody bags and future distribution of club t-shirts and any other items. Will also be used in the event that future COVID health and safety guidelines permit in-person meetings.

# Redbook Name/Duty/Membership Alterations

WHEREAS, ASUU members, specifically the Vice President of University Relations, Student Resources Board Director and Student Resources Board Associate Director, have been invited to collaborate and share student feedback on a Student Health Insurance Advisory Committee and;

WHEREAS, ASUU's <u>purpose</u> is to advocate on behalf of all University of Utah students to amplify and voice their concerns and;

WHEREAS, the Vice President of University Relations, Student Resources Board Director and Student Resources Board Associate Director hosted a town hall in October and heard that several student concerns regarding the structure of the Student Health Insurance plan, along with the negotiating and structural processes and;

WHEREAS, the Vice President of Student Relations is tasked with "..promot[ing] a reciprocal relationship between the ASUU Government and University students.." per Redbook Article II.I Section 3, Duties, 1.1 and;

WHEREAS, campus safety has been an especially contested and talked about issue for multiple years and;

WHEREAS, the McCluskey Center for Violence Prevention (MCVP) has become a foundational preventative measure to boost campus safety and major collaborations were made between the MCVP, ASUU, and the Lauren McCluskey Center Foundation for the 2020-2021 academic year and;

WHEREAS, the Public Safety Advisory Committee is tasked with creating and maintaining transparency and meaningful change in the realm of campus safety and;

WHEREAS, the Vice President of Student Relations and Vice President of University Relations are responsible for garnering feedback and collaboration with students at large and;

WHEREAS, the co-chair of the Public Safety Advisory Committee is responsible for garnering feedback and collaboration with students at large around campus safety and;

WHEREAS, the "Campus Student Leadership" name has been changed de facto in historical precedent for the past 3 years and;

WHEREAS, the "Student Leadership Council" is a more accurate name for the task at hand which is, "to collaborate in programming and events and to promote a sense of community among student leaders of the University" (per Redbook Article 11.1, section 3, 1.4). and;

WHEREAS, the Nontraditional Student Immersion and Outreach Director knows student-parent populations well and would be a key stakeholder in a committee centered around scholarship distribution for this population and;

WHEREAS, the Associate Director for Budget and Finance through Student Leadership and Involvement has the dollar amount needed for the ASUU Scholarship board to distribute the correct scholarship amount.

THEREFORE, BE IT FUTHER ENACTED, that the Vice President of University Relations Duties Article II.I (Section 2) are altered to add in the following duties:

- o 1.2.6 Student Health Insurance Advisory Committee
- o 1.2.7 McCluskey Center for Violence Prevention Advisory Committee
- o 1.7. To host, promote, and/or collaborate with the Lauren McCluskey Foundation for an annual memorial service in honor of Lauren McCluskey

THEREFORE, BE IT FURTHER ENACTED, that the Vice President of Student Relations Duties Article II.I Section 3.1 are altered to add in the following duty:

- 1.7 To co-chair the Public Safety Advisory Committee under the purview of the Department of Public Safety.
- 1.7.1 To host a Safety Town Hall with members of the Public Safety Advisory Committee as panelists each year, and use this Safety Town Hall as a way to garner student feedback on campus safety.

THEREFORE, BE IT FURTHER ENACTED, that the name of the "Campus Student Leadership" shall be changed to be read as the "the Student Leadership Council". This change shall be implemented in all areas where previously the "Campus Student Leadership" is referenced in Redbook including Article II.I Section 3: 1.4., 1.41, 1.4.2.

THEREFORE, BE IT FURTHER ENACTED, that the Student Resources Board Duties (Section 11) for Student Resources Board Director and Associate Director are altered to add in the following duties:

- 2.1.7 To serve as a member of the Student Health Insurance Advisory Committee if the Associate Director can no longer fulfill that role either temporarily or permanently.
- o 2.1.8 To plan and host an ASUU town hall surrounding Student Health Insurance once a semester
- o 3.1.3 To serve as a member on the Student Health Insurance Advisory Committee and serve as a negotiating member on behalf of student health insurance
- o 3.1.4 To plan and host an ASUU town hall surrounding Student Health Insurance once a semester

**THEREFORE BE IT FURTHER RESOLVED** that the following addition be made to the duties of the Director of the Student Resources Board through Article II.II Section 2.1 of the Bylaws of Redbook: "2.1.7: To advance legislation related to campus safety initiatives."

# A BILL TO INCLUDE THE DIRECTOR OF DIVERSITY AS AN EX-OFFICIO MEMBER OF THE LEGISLATURE

WHEREAS, ASUU passed Joint Resolution 1 and Joint Resolution 2 during the summer of 2020 with the goal of creating a more diverse, equal, and inclusive campus.

WHEREAS, per Redbook, the Director of Diversity is to serve as the ASUU Government's liaison to all student organizations and University offices which promote diversity on campus, in accordance with University policies.

WHEREAS, legislature meetings and decisions at times have suffered from a lack of representations of marginalized communities. The exclusion of those voices has led to bills and resolutions that do not take into consideration the voices of these communities.

WHEREAS, the Director of Diversity may provide an additional and invaluable voice for BIPOC, LGBTQIA+, international, and undocumented students during legislature debates.

WHEREAS, the Director of Diversity's role is more important than ever in our legislature as ASUU and the University move forward with anti-racist values, equity, and inclusion.

WHEREAS, the Director of Diversity may provide reports to the legislature on progress made by ASUU, the Diversity Board, and the University towards achieving the goals in Joint Resolution 2 and/or of any progress, or lack thereof, while working with the Student Affairs Diversity Council.

THEREFORE, BE IT ENACTED that the following language be modified in Redbook:

# ARTICLE I.I – ASSEMBLY BYLAWS

# Section 1 – Membership

The Assembly will be composed of the number of university Colleges multiplied by two, elected from among all the Colleges of the University.

The officers of the Assembly will be composed of an Assembly Chair, a Vice Chair, a Parliamentarian, a Treasurer, and the Committee Chairpersons, herein referred to as the Assembly Rules Committee.

The Vice President of Student Relations, the Director of Campus Relations, the Director of Finance, **the Director of Diversity**, and the Attorney General will serve as exofficio members of the Assembly.

# ARTICLE I.II – SENATE BYLAWS

# Section 1 - Membership

- 1. The Senate will be composed of a Senator from each University College as specified in the Constitution, Article III, Section 4.
- 2. The Vice President of University Relations, the Director of Academic Affairs, the Director of Finance, **the Director of Diversity**, and Attorney General will serve as ex-officio members of the Senate.
- 3. The officers of the Senate will be composed of a Senate Chair, a Vice-Chair, a Parliamentarian, a Secretary, and a Treasurer. These officers are herein referred to as the Executive Committee.

# A BILL TO CLARIFY REDBOOK LANGUAGE REGARDING FINE ARTS ORGANIZATIONS

WHEREAS, Redbook's **ARTICLE IV**, **Section 6**, **Clause 12** reads: "The ASUU Government will not fund fine arts organizations. All fine arts organization requests should be forwarded to the College of Fine Arts. A fine arts organization is a group or individual which primarily engages in fine arts activities and is recognized as an official Fine Arts group or organization by the College of Fine Arts or any of its departments."

WHEREAS, the language of the clause is vague and confusing. Therefore, it makes it difficult for College of Fine Arts ASUU Assembly Representatives to pass bills from fine-arts-oriented Registered and Affiliated student organizations.

WHEREAS, all students pay the ASUU Activity Fee (\*) and the FAF Grant Fee; yet, College of Fine Arts Sponsored groups cannot access ASUU Funding that may be used as additional funding for club related events. CFA Sponsored clubs can only apply for funding from the FAF Grant Fee program.

WHEREAS, per the Office of Budget and Institutional Analysis, "the Fine Arts Fee supports various arts and culture resources on campus, including the Arts Pass program. This program provides free or greatly reduced tickets to all matriculated University of Utah students for various campus performances, productions, exhibitions, and other cultural events. A small portion of the funds also support FAF grants, the Fine Arts portion of ASUU student group fees, which offers grants to student groups." Yet, this statement only refers to College of Fine Arts Sponsored groups. This does not apply to groups or organizations that are recognized with the office of Student Leadership and Involvement as RSO or Affiliated Students Organizations composed of Fine Arts students, or whose mission is the arts.

WHEREAS, per the CFA website\*\*: "FAF Grants funding is available to College of Fine Arts student groups that are registered as a Sponsored Student Organization through Student Leadership & Involvement. CFA Sponsored Student Organizations may apply for FAF Grants to fund student-driven, noncredit projects that enhance student learning, and/or enhance the student experience for the larger University community, and/or create or host arts events on campus or in the greater Salt Lake Area. FAF Grants projects must originate in the College of Fine Arts, be advised by a College of Fine Arts faculty member, and may involve students from other colleges."

WHEREAS, All students benefit from the FAF grant sponsored events and the work done by students in Fine Arts Sponsored organization at no cost. Therefore, both fees serve, directly or indirectly, all University of Utah students.

**THEREFORE, BE IT ENACTED** that the following language be modified in Redbook. **ARTICLE IV, Section 6, Clause 12** shall read: "The ASUU Government will not fund fine arts organizations that are sponsored by the University and the College of Fine Arts. All fine arts organizations dealing with sponsored group requests should be forwarded to the College of Fine Arts. A Sponsored Fine Arts organization is a group or individual which primarily engages in fine arts activities and is recognized as an official, sponsored Fine Arts group or organization by the College of Fine Arts, or any of its departments. Registered Student Organizations or Affiliated Organizations composed of Fine Arts students or that promote the Arts will be eligible for ASUU funding."

#### **Joint Resolution:**

Denouncing Hate Speech Across College Campuses Authors: Michelle Valdes, Ayana Amaechi, Momina Sial, Arunabh Sarkar, and C.J. Reid

Working definition of hate speech as derived in part from the <u>United Nations</u> and the <u>University of Utah Non-Discimination Policy 1-012</u>: any kind of communication in speech, writing or behaviour, that attacks or uses pejorative or discriminatory language with reference to a person or a group on the basis of who they are, in other words, based on their religion, ethnicity, nationality, race, colour, disability, descent, gender identity, or sexual orientation.

WHEREAS, numerous hate speech instances have occured on the University of Utah campus in the past and;

- 1. 2012 professor was verbally prejudiced against the LDS faith
- 2. 2017 posters found outside of the Student Life Center
- 3. 2017 vandalism of Gardner Commons Building during construction
- 4. 2019 multiple stickers and a banner displayed linked to hate groups
- 5. 2020 racial slur written into the frost of a car window
- 6. 2020 unapproved posters found near the Student Services Building
- 7. 2020 <u>racial slur</u> written on bulletin board in one of the Housing and Residential Education Buildings
- 8. 2020 BLM sign was defaced

WHEREAS, these instances create an environment that separates BIPOC students from the campus in general and;

WHEREAS, feelings of separation are contrary to the "sense of belonging" that contributes to college student retention and persistence (O'Keeffe, 2013; Strayhorn, 2018) and;

WHEREAS, students of color at the University of Utah and other predominantly white institutions (PWI) may feel separated from campus and the <u>college experience because of racial stressors</u>. Per student testimonial, these feelings of separation could impede academic success by creating an environment that could motivate students to leave the institution and may hinder academic success, as seen most recelenty in testimonial and conversations during the passage of JR2.

WHEREAS, hate speech <u>silences the target group</u> (Pg. 788) or individual, minimizing their contribution to public discourse and effectively destroying the free trade of ideas and;

WHEREAS, the current <u>Student Bill of Rights</u> affirms that "[s]tudents have a right to support and assistance from the University in maintaining a climate conducive to thinking and learning. University teaching should reflect consideration for the dignity of students and their rights as persons. Students are entitled to academic freedom and autonomy in their intellectual pursuits and development. Students have a right to be treated with courtesy and respect.", and;

WHEREAS, University of Utah employees are professionally bound to abide by <u>Policy 1-012</u> which states that employees cannot conduct themselves in an abusive manner whether that be physical, verbal, and/or non-verbal; they also are not permitted to intend harm or unwarranted distress, humiliate, and/or intimidate students in a way that may exploits a known physical or psychological disability and;

WHEREAS, the University of Utah has <u>denounced hate speech</u>; however, the act of combatting and enduring continued hate speech is disproportionately placed on the shoulders of BIPOC students and organizations in ASUU, the Black Student Union, Center for Ethnic Student Affairs, and others and;

WHEREAS, this act of denouncing hate speech as a member of the BIPOC community can and does cause racial battle fatigue (RBF) and;

1. Racial battle fatigue can cause both physical and mental harm as stated in this article.

WHEREAS, the University of Utah recently (2020) wrote an @theU article that featured Dr. William Smith, a faculty member in the College of Education (Education, Culture, and society) who spoke about the gravity of racial battle fatigue and;

1. Microaggression and Racial Battle Fatigue

WHEREAS, though free speech is consistently cited as the foundation as to why challenging hate speech is impossible, there is continual movement and constant precedent in challenging what is protected under the First Amendment in the law and outside such as:

- 1. In the 1942 SCOTUS case, <u>Chaplinsky v. New Hampshire</u>, it was ruled that speech that "tend[s] to incite an immediate breach of the peace" is unprotected under the First Amendment and;
- 2. In the 1964 case, <u>Cox v. Louisiana</u>, the Supreme Court ruled in favor of peaceful demonstrators, but acknowledged that freedom of expression is a qualified right, not an absolute and:
- 3. In the 1973 SCOTUS case, <u>Miller v California</u>, where it was ruled that obscenity was unprotected speech under the First Amendment and;
- 4. In the 1985 case, <u>Cornelius v. NAACP Legal Def. and Educ. Fund, Inc.</u>, where the Supreme Court ruled that nothing in the Constitution requires the Government to grant access to all who wish to exercise their right to free speech on every type of Government property without regard to the nature of the property or, to the disruption that might be caused by the speaker's activities and;

WHEREAS, there is movement and active conversations in <u>institutions of higher education</u> most recently, in 2020, as to the <u>where the lines should be drawn</u> between hate speech and the First Amendment without other considerations and;

WHEREAS, hate speech specifically, disrupts rules and regulations set forth by the University by failing to promote diversity, equity and inclusion and fails to abide by the University of Utah mission statement that aims to "foster[s] student success by preparing students from diverse backgrounds for lives of impact as leaders and citizens" as displayed in this mission statement and;

1. Mission Statement from Academic Affairs

WHEREAS, limiting hate speech and having a productive marketplace of ideas are not mutually exclusive, and hate speech promotes narrow mindedness—not open mindedness—because one can limit hate speech without limiting challenging viewpoints and;

WHEREAS, the First Amendment protections of speech conflict with the Freedom of pursuit of life, liberty and happiness. Such as the effects on BIPOC students and citizens that hate speech can cause (listed above) and;

WHEREAS, the University of Utah holds "diversity, equity, and inclusion" to the highest regard and constantly prioritizes these goals in strategic planning moving forward, such as the addition of a Vice President for Equity, Diversity, and Inclusion and;

WHEREAS, the University of Utah takes pride in its students changing the world and encourages students to constantly challenge the status quo and create meaningful change in research, policy, education, and beyond.

THEREFORE BE IT RESOLVED, that the Student Code of Conduct (Policy 6-400 Section 3A3) is revisited and it is seriously considered that it be changed to incorporate hate speech as a standard of behavior subject to behavioral sanctions, or mandatory educations, on a case by case basis, that may include, but not be limited to, the following:

- A written reprimand
- The imposition of a fine or payment of restitution
- Community service
- Probation
- Suspension
- o Dismissal from the University of Utah.

THEREFORE BE IT FURTHER RESOLVED, that the Non-Discrimination Policy (Policy 1-012) is revisited and there be a serious consideration that the discrimination definition (2-D-1) is changed to incorporate hate speech as part of a standard of behavior subject to behavioral <u>sanctions</u>, or mandatory educations, on a case by case basis, that may include, but not be limited to, the following:

- A written warning
- Reduction in pay
- o Probation
- Suspension without pay
- o Demotion
- o Dismissal from employment at the University of Utah.

THEREFORE BE IT FURTHER RESOLVED THAT, there be a working group created within the Student Affairs department, including, but not limited to, student, staff, and faculty, who will continue considering University policy changes to formally denounce hate speech and/or advocate against hate speech on behalf of the University of Utah in spaces like the legislative cycle and the USHE report on a yearly basis.

THEREFORE BE IT FURTHER RESOLVED THAT, that this legislation is passed on to all college campuses in the state of Utah, and distributed to the PAC-12 schools via their respective student governments by the Associated Students of the University of Utah (ASUU).

THEREFORE BE IT FURTHER RESOLVED THAT, this legislation is distributed by the ASUU to the following offices within 30 days:

- 1. The Office of the President;
- 2. The University of Utah Athletics Department;
- 3. The Office of the Dean of Students
- 4. The Office of Equity, Diversity, and Inclusion

- 5. The Director of Student Leadership and Involvement;
- 6. The University of Utah Alumni Association;
- 7. The University of Utah Board of Trustees;
- 8. The Utah Board of Higher Education;
- 9. The Associate Vice President of Faculty;
- 10. University Marketing and Communications;
- 11. The Center for Ethnic Student Affairs (CESA);
- 12. The Black Cultural Center (BCC)
- 13. The Utah Student Association (USA)
- 14. Office of Fraternity and Sorority Life
- 15. The Dean's Office for all 18 colleges at the University of Utah;
